Update on Stanton COO Question

What is the wait time for hip & knee replacement surgery? A patient can expect to wait approximately 2 years (or 96 weeks or 672 days) for an elective joint surgery in the NT.

- The STH 2024-25 waitlist report table says Ortho is 196 for December 2024.
- The usual time frame from initial consultation (assessment) to being booked for a joint surgery is 24 - 48 weeks or 5.5 to 11 months.
- 4 joint surgeries are performed every week. This number can be impacted by the availability of surgeons and inpatient beds.
- To reduce wait times joint replacement surgeries are now happening over the Christmas break, during the March break & during the summer. The surgical unit was not open during these times in the past.
