8. RWC Member Observations and Comments

Mr. Vince Teddy

- Raised a comment on the how RWC may be seen as advisory, that advisory power has benefits for the minister for the communities and for the department, how do we go about improving daily life?
- Comment on the Governor General Auditor general's report does say there is problems, the community visits, the problems are there now how do we improve and address the problems,
- Raised a concern on staff shortages, doctor goes to Tuktoyaktuk, there is only 2 nurses one
 has to help the doctor, one nurse to see the daily patients

Ms. Denise McDonald

- Raised a comment on how do we remind the people we are the ones down here
- Raised a concern about relationship and respect, helping reciprocity, need to be reminded so many people are filled with negativity and drama
- Would like to be updated on a number of children in foster care, the AOG recommendations were not being followed, what is in place and these are the recommendations following through, foster care new solutions found in foster care, the children that are stepping up now, not only in north, happening in Canada,
- Raised a concern that some people on medical travel come into Inuvik without id, cannot go on the plane without id, some mechanism in the communities, get photo ideas
- Raised a concern that somebody that is illiterate, does not have family support help, elders in care, a lot come under trustee, need someone in the region,
- Questions around cannabis, people are not clear on the impact particularly on youth,

Ms. Ellen Smith

- Raised a concern on how to deliver the health care system
- Raised a concern that there is no assistance in the community, what is available for mental health issues

Ms. Donna Keogak

 Only concern was that the doctor did not make it to Sachs Harbour, the community has been waiting a month.

11. Open to the Public

Territorial/Regional/Community

- Notice for the meeting in Aklavik was not advertised, no one knew about the meeting
- Nurses make patients feel rushed after waiting for an hour, then just see them for 5 minutes
- Health Centre in Aklavik is understaffed
- Staff with bad behaviour or unacceptable behaviour this needs to be addressed through the proper NTHSSA HR channels if the health authority expects to see the bad behaviour stop or improve
- Referrals
 - o How long do they take?
 - Not updating with the patient
 - o What is the process? Who do you call?
- Orientating Nurses is utmost importance when they arrive into the community
- Social Workers
- Why losing so many either resigning or retiring
- Need a support person in each Health Centre, for people that do not understand medical terms
- Wait time to see specialist means long wait time for treatment that could potentially save lives
- One mental health worker in the community, gone all the time, should have a relief counselor, like there is relief workers for nurses.
- Support for men same as support provided for woman and children. We need to lose the stigma of men needing or not needing support.
- Lack of mental health and addictions,
- No AA meetings,
- No support for people that return from treatment
- Young people have nowhere to turn but drink
- Do not want to see mental health worker at health centre; stigma of what people might think.
- What is available in the community for mental health issues?

Medical Supplies



 When a patient needs over and above medical supplies on what doctor prescribes; have to fill out an application; then it goes to the Minister's office for approval

Regional/ Community Specific

- Community does not have a regular doctor in the community, see which ever doctor is visiting and have to tell your illness over and over again
- Concerns over files confidentiality health and social services not adhering to it in the past

Issues or Concerns to bring forward to Leadership Council

- Auditor General is not addressing what the communities are saying, it is a hard task the DHSS and the NTHSSA BDR should address together
- No respite care in the communities, have to go to Inuvik

Ms. Gruben asked the board if there are any other recommendations to address for the next Leadership Council meeting, besides what was previously addressed? No other recommendations were raised.
