- An update on the meetings the Chairperson has had, both in person and by phone, with the Minister. The Chairperson identified that he has a good working relationship with the Minister of Health and Social Services and the Department of Health and Social Services.
- Informing Leadership Council members that the Minister has invited the Leadership Council members to accompany him on a visit to Poundmakers Treatment Center in early August.

- Informing Leadership Council members that the Chairperson has been invited to attend the northern policy framework development hosted by Dene Nahjo.
- Informing Leadership Council members that the Chairperson was asked by Dechinta University to participate in their canoeing program.
- Sharing with Leadership Council Members that on May 5th, the Chairperson had a tour of Stanton Territorial Hospital to see the operations of the sterilization equipment and the current issues related to the steaming equipment.
