## Chair, Beaufort Delta Regional Wellness Council

Ms. Ethel-Jean Gruben was most recently appointed by the Minister on January 2, 2024, for a 2.5-year term. She resides in the Town of Inuvik on the east channel of the Mackenzie River delta. Mrs. Gruben previously served six consecutive years in this role from 2016 to 2022.

Mrs. Gruben has a background in human resources, and enjoys working for the Inuvialuit Regional Corporation. She is active in the Inuvialuit cultural community and serves on the Environmental Impact Review Board over-seeing environmental reviews of development projects within the Inuvialuit Settlement Region.



## Chair, Sahtu Regional Wellness Council

Ms. Gina Dolphus was most recently appointed by the Minister on January 1, 2023, for a 1.5-year term. She lives in the community of Délı̨ne on the western shore of Great Bear Lake. Ms. Dolphus previously served six consecutive years in this role from 2016 to 2022.

Ms. Dolphus has a background in social work, and is currently a member of the Department's Indigenous Advisory Body and a Councillor for the Délı̨ne Got'ı̨ne Government.



## Chair, Dehcho Regional Wellness Council

Mr. Muaz Hassan was appointed by the Minister for an initial term of three years on August 1, 2023. He lives in the Village of Fort Simpson, at the confluence of the Liard and Mackenzie Rivers.
